



LIMITED WARRANTY

Corpair Supply, Inc. (“CORPAIR”) warrants, subject to the terms, conditions and exclusions hereinafter set forth in this limited warranty (“Warranty”), that the parts and services delivered by CORPAIR are in accordance with manufacturer’s requirements, specifications, and mandatory service bulletins up to and including the date of service. CORPAIR warrants each part, component, or accessory sold, repaired or overhauled by CORPAIR to be free from defects in material and workmanship, under normal use in the manner prescribed by the original equipment manufacturer for a period of SIX (6) months from the date of Invoice. Any part, component, or accessory sold, repaired, overhauled, or serviced by an Original Equipment Manufacturer (“OEM”) or vendor for CORPAIR shall be covered by the OEM or vendors warranty, if offered, subject to the terms and conditions of that OEM or vendors warranty. If the OEM or vendors warranty has expired as of the date of Invoice, CORPAIR shall provide a limited warranty in accordance with the terms of the CORPAIR Warranty for a period equal to the OEM or vendors warranty period or ninety (90) days from the date of Invoice, whichever date is earlier.

TERMS & CONDITIONS

- a. Customer must notify CORPAIR by prompt written notice upon the discovery of any alleged defect in workmanship or part prior to the expiration of the Warranty;
- b. Customer must return the part to CORPAIR along with original documentation (8130, etc.), postage and handling prepaid, for Warranty consideration;
- c. Warranty does not apply if the part alleged to be defective has not been maintained and operated by the Customer or its agent in accordance with the manufacturer’s recommendations, manuals and service bulletins;
- d. Warranty does not apply if the part alleged to be defective and/or its component parts have been repaired or altered by any firm or entity other than CORPAIR or an authorized agent of CORPAIR;
- e. Warranty does not apply if the alleged defective part has been subjected to misuse, neglect, accident or other damage;
- f. Parts eligible for Warranty claim shall be repaired or replaced at the sole discretion of CORPAIR;
- g. Parts repaired or replaced in a repair under this Warranty shall not extend the original Warranty period set forth above;
- h. CORPAIR will only honor replacement parts with an identical or similar part made by the same manufacturer as generally sold by CORPAIR;
- i. CORPAIR shall prorate Warranty on all TBO, Life Limited, and Wear Limited Items
- j. On all parts, Warranty covers only the parts repaired or replaced by CORPAIR. This Warranty extends only to CORPAIR’s Customer.
- k. Warranty does not apply to Customer supplied part(s), or any damage resulting from the malfunction or failure of the Customer supplied part(s).

Claim Procedure: Any claim under this Warranty shall be initiated by obtaining a Return Material Authorization (“RMA”) from CORPAIR WARRANTY CLAIMS via telephone (636) 272-2266, fax (636) 272-0844 or letter to CORPAIR WARRANTY CLAIMS, 827 Texas Court, O’Fallon, MO 63366. Upon obtaining a RMA, delivery of the part or parts alleged to be defective shall be delivered to CORPAIR for warranty claim evaluation and disposition. All part(s) must be accompanied by copies of all appropriate paperwork identified on the RMA Checklist for the previous service or delivered part.

CORPAIR SHALL NOT BE LIABLE FOR ANY INCIDENTAL, INDIRECT, SPECIAL OR CONSEQUENTIAL DAMAGES WHATSOEVER (INCLUDING, BUT NOT LIMITED TO, LOSS OF USE, LOST PROFITS, OR BUSINESS EXPECTANCY) ARISING OUT OF THE USE, OR INCAPABILITY OF USE, OF SERVICES PERFORMED OR PARTS PROVIDED BY CORPAIR. CORPAIR AGGREGATE LIABILITY UNDER THIS LIMITED WARRANTY, WHETHER ARISING IN CONTRACT OR TORT, SHALL NOT EXCEED THE COST OF SERVICES PERFORMED OR THE PARTS SOLD BY CORPAIR. THIS WARRANTY IS CUSTOMERS SOLE AND EXCLUSIVE REMEDY FOR WARRANTY CLAIMS. THIS WARRANTY IS LIMITED TO THE TERM OF THE EXPRESS WARRANTY ABOVE. THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS, AND YOU MAY ALSO HAVE OTHER RIGHTS THAT VARY FROM STATE TO STATE.
